Here are some issues the Trust has been dealing with recently.

20 MPH VILLAGE SPEED LIMIT The Trust is pleased to report this has been agreed by Herts County Council and funding has been allocated to implement this. The Trust will be liaising with HCC over introduction in 2024/25.

BATTERY ENERGY STORAGE SYSTEM The Trust has held 3 open meetings to raise awareness of this proposal and has recently presented to Radlett residents. The Trust has also met with The Manor and nearby schools. We'll let you know when the application is made and how you can make objections.

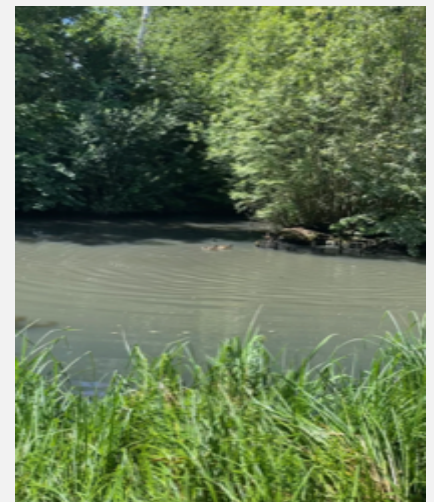
VILLAGE POND The Trust liaises closely with Aldenham Parish Council regarding its responsibility to upkeep the pond. Progress is being made on planning necessary cleaning and upgrading works. The Trust is working towards agreeing a 10 year plan with APC which will secure residents' enjoyment of this important Village feature.

CHRISTMAS TREE The Trust aims to have this installed by the Three Horseshoes in early December and has secured some outside funding. We will be asking residents to make small donations to help achieve this.
